McLAREN SHAREHOLDERS VOTE OVERWHELMINGLY FOR NEW SHAREHOLDER-NOMINATED BOARD

McLaren Resources Inc. (the "Company") (CNSX: MCL; FWB: 3ML) is pleased to announce that the shareholders of the Company voted on 10 March 2009 to elect a new, independent and experienced Board of Directors to work for the benefit of all shareholders. The new board of directors consists of John Holko, Victor Childs, Ivan Buzbuzian, Paul Crath and Michael Meredith.

Immediately following the special meeting, the Board appointed Michael Meredith as interim President and Chief Executive Officer and Nadim Wakeam as Secretary.

The Board intends to continue advancing the Company's North Sea project and to review additional opportunities. Further updates will be released to shareholders on a regular basis. In particular, the Board intends to release updates on the Dutch North Sea property partnership which is operated by Ascent Resources plc.

Mr. Holko has over 25 years' experience in the oil and gas industry. In 1995 Mr. Holko proceeded with a management buyout of Lenape Resources from its parent KCS Energy. Lenape is a petroleum exploration and production company which owns and operates interests in several hundred oil & gas wells in the Appalachian Basin. Mr. Holko's experience encompasses all
